

**ADULT DAY HEALTH CARE (ADHC) / COMMUNITY BASED ADULT SERVICES (CBAS) CENTER
AVAILABLE IN ALAMEDA COUNTY****ACCEPTING APPLICATIONS****BACKGROUND**

Stakeholders from across Alameda County recognize the need for greater ADHC/CBAS capacity in the County to meet the current and growing need for services arising from demographic trends, program closures and the upcoming Coordinated Care Initiative (CCI). CCI will require the mandatory enrollment of over 23,000 dual eligibles into Medi-Cal Managed Care starting in September 2013 and is expected to increase demand for Adult Day Services significantly.

Currently, there are five ADHC/CBAS centers in Alameda County: two in downtown Oakland, two in Berkeley and one in Hayward. A proposed new center in Fremont is in the planning stage. Last year, LifeLong Medical Care, a Federally Qualified Health Center, closed its ADHC/CBAS center in East Oakland after state budget cuts significantly reduced health center reimbursement for CBAS services. This ADHC/CBAS license has been placed in voluntary suspense until September 2013, thereby preserving the potential for a new ADHC/CBAS center in the County.

OBJECTIVE

A reputable provider will acquire LifeLong Medical Care's ADHC and open an ADHC/CBAS center in the County that helps to meet the current and growing need.

THE LICENSE:

Dual ADHC/ADP with CBAS Certification.

Capacity: 60 (provider can petition to increase capacity)

Location: 10700 MacArthur Blvd., Suite 14A, East Oakland. This location may be available, but is not guaranteed. The new provider can petition for a change of location.

APPLICATION REQUIREMENTS AND DUE DATE

Interested providers should submit a Letter of Intent (LOI), including:

- Profile/history of previous ADHC or related experience
- General outline of the new ADHC plan: proposed location, capacity, specialty if any
- Timeline for start-up
- References
- Technical Assistance Needs: Alameda County wants to be supportive to the opening of a new program. Please include a list of technical assistance and support you might need.
- Tax Return for most recent year.

Due Date: Beginning March 15, 2013, LOIs will be reviewed on a rolling basis and a reputable provider with a viable plan may be selected anytime thereafter. Applicants may contact the Adult Day Services Network for a status report.

SELECTION PROCESS AND CRITERIA

LifeLong retains the sole right to select a provider to acquire its business and will do so based on the criteria below and subsequent discussions with selected applicants.

ADHC/CBAS Center: Application Process

Selection Criteria

The following criteria will be used to assess the merits of the Letters of Intent.

- Previous ADHC or related experience
- Ability to serve participants with complex medical and mental health conditions
- Cultural competence with a cross section of local population
- Sustainable business plan
- Ability to fulfill license requirements and complete Change of Ownership within one year
- Program Location: Stakeholders believe the greatest need is for a new center in Central Alameda County
